

OFFICIAL RAFFLE RULES AND CONDITIONS:
Saskatchewan Community Foundation - Blades 50/50 ("Raffle")

OFFICIAL RULES: By participating, entrants agree to be bound by these Official Rules and by the decisions of **Saskatchewan Community Foundation**, which shall be binding and final as to all matters related to the Raffle. The Raffle is operated under Provincial Lottery License No. **TBD** and is subject to all applicable federal, provincial and local laws.

PROCEEDS: To Saskatchewan Community Foundation

PRIZES: Winner will receive 50% of the Total Raffle Sales. ("Prize")

ELIGIBILITY TO ENTER: During the dates and times and other details specified below, raffle tickets are available for purchase by anyone regardless of their residence if tickets are purchased in person at the game from volunteers selling via handheld terminals or at kiosks on the concourse. Online purchases available at www.sask-5050.ca if the purchaser is located in Saskatchewan. On-line sales will start at 9:00am the day before game day. All sales will end at 10 minutes remaining in the third period.

Any **employees of the organization or people involved in the conduct and management of the raffle, including immediate family of these people**, are not allowed to purchase tickets. Must be 18+ to play.

PURCHASING RAFFLE ENTRIES: The following prices and corresponding "ticket numbers" are available for purchase: **10 tickets for \$20, 50 tickets for \$50, 250 tickets for \$100 and 750 tickets for \$200 for all regular season and playoff games beginning September 26, 2026 and ending May 31, 2027 except October 02, 2026.** Ticket sales will be available for purchase online at www.sask-5050.ca and advertised as such.

Online sales for the season opener on September 26, 2026 will begin on September 01, 2026.

A season-long subscription option is available for eligible participants, excluding the game on October 02, 2026. Individuals may self-register for a subscription for this licence only, that automatically purchases 50/50 tickets for all remaining events in the raffle period. Subscription purchasers must meet all eligibility requirements, and individuals involved in the conduct, management, or sale of the raffle—including their immediate family—are not permitted to subscribe or purchase tickets.

NUMBER OF RAFFLE TICKETS: There will be 14,814,814 tickets available for purchase, with the ticket prices and amounts available for purchase are as follows:

- 10 for \$20.00
- 50 for \$50
- 250 for \$100
- 750 for \$200

Total possible prize value of \$4,000,000

THE DRAWS: A 50/50 raffle and draw will be held for all regular season and playoff home games for the 2026/27 hockey season September 26, 2026, and run until May 31, 2027,

except October 02, 2026. All draws will take place at SaskTel Centre; 3515 Thatcher Ave; Saskatoon, SK S7R 1C4 at the 10 minutes remaining mark of the 3rd period of the hockey game. The winning ticket is drawn electronically by random number generator approved by SLGA. The winning ticket number will be announced over the public address for all home games. Ticket must be presented to claim prize and the number on the ticket must match the random generated number. If the winning ticket was purchased online, the purchaser will be contacted via telephone per the information they submit at time of online purchase. The winning number will also be posted online at www.sask-5050.ca

The winner will have 365 calendar days from the draw date to claim their prize. If the prizes go unclaimed beyond their hold date, the prize shall be donated to a charitable beneficiary approved by SLGA in accordance with Section 13(d) of the SLGA's Terms and Conditions.

GUARANTEED PAYOUTS

Certain regular-season and playoff games will feature **guaranteed payouts of \$5,000**. All guaranteed payout amounts will be supplied by Saskatchewan Community Foundation. The following games will include an advertised guaranteed payout:

- Guaranteed **payout of \$5,000** for all home games against the PA Raiders and Regina Pats
 - o **PA Raiders:** September 26, 2027, December 27, 2026, January 24, 2027 and March 27, 2027
 - o **Regina Pats:** October 10, 2026, November 10, 2026, December 06, 2026 and March 19, 2027
- Guaranteed **payout of \$5,000 for all playoff home games** running between March 31, 2027 – May 31, 2027. Dates TBD and will be provided to SLGA before any tickets are sold for the games.

DETERMINATION OF OFFICIAL WINNER(S): Saskatchewan Community Foundation shall have the sole discretion to determine whether each Potential Winner is an official winner of a Prize (an "Official Winner"). The Saskatchewan Community Foundation's decision concerning the identity of all Official Winners shall be final and binding. To become an Official Winner: (1) a Potential Winner must be eligible to participate in the Raffle under these Official Rules and must not be in violation of these Official Rules as determined in Saskatchewan Community Foundation's sole judgment; (2) that Potential Winner must claim the prize by the deadline specified above.

The winner must provide his/her name, address and phone number with picture identification to claim the prize. A scan of a valid provincial or federal photo identification card (i.e., driver's license, firearm possession permit, passport, etc.) is acceptable.

AWARD OF PRIZE(S) TO OFFICIAL WINNER(S): A Prize will be awarded to the Potential Winner who has been awarded by the Saskatchewan Community Foundation as an Official Winner. The winner's name will be published. All prizes will be awarded to the Winner via cheque or e-transfer. For security and auditing purposes, no cash payments will be made to winners.

Any change to the licence will receive prior approval from SLGA. All Entry purchases shall be final, and no refunds or replacements will be issued by the Saskatchewan Community Foundation. The Saskatchewan Community Foundation's sole and final decision on admissibility of entries and the determination of prize winner.
